- (b) the numbers of registered foreign lawyers in Hong Kong in the past 5 years?

According to the information published by The Law Society of Hong Kong (the Law Society), the overall pass rates for the Overseas Lawyers Qualification Examination (OLQE) were as follows¹:

Year	Overall pass rate for the OLQE
2022	20%
2021	39%
2020	52%
2019	45%
2018	49%

Question:

- (a) The estimated total expenditure for the Guangdong-Hong Kong-Macao Greater Bay Area (GBA) mediator training courses and the GBA lawyers' practical legal training course in 2024-25 is only \$100,000, far lower than that for the talent training programmes in other sectors in the same year. What are the reasons?
- (b) The number of beneficiaries of the Understudy Programme launched by the Department of Justice for training legal talents is less than 100 each year, which is significantly lower than the annual number of graduates from the 3 law schools in Hong Kong. What are the reasons?

Reply:

- (a) As talent training programmes in different sectors vary in scale, criteria and budgets, direct comparison amongst the programmes may not be appropriate.

The Guangdong-Hong Kong-Macao Greater Bay Area (GBA) mediator training courses will be held for the first time in 2024-25. As the venue and manpower required will be provided by the Department of Justice (DoJ), we have initially earmarked \$100,000 for the other expenditures of the training courses. Should additional resources be required, they will be absorbed through deployment of existing resources of the DoJ.

With regard to the GBA lawyers' practical legal training course to be co-organised by the DoJ and relevant Mainland bodies, the course is non-profit making and it is expected that the expenditure will mostly be borne by the co-organisers. The DoJ's relevant expenditure will be absorbed by its existing resources.

- (b) The Understudy Programme of the DoJ targets at qualified barristers and solicitors with less experience (i.e. lawyers with less than 5 years of post-call/admission experience), and not all law school graduates who become lawyers will apply to join the Programme. The DoJ has to consider and select suitable cases/legal research work before inviting

these barristers or solicitors to take part in them. As such, the number of beneficiaries each year depends on the number of participants of the Programme and the availability of suitable work. Since the launch of the Programme in mid-2020 to 29 February 2024, over 60% of eligible participating barristers and solicitors have taken part in various civil and criminal work through the Programme. The DoJ will continuously review and select suitable work to provide more training opportunities to participating barristers and solicitors.
