毅柏律师事务所曾担任曹操出行有限公司(连同其子公司,称"曹操集团")的开曼法律顾问,帮助 其于2025年6月25日在香港联合交易所主板成功上市,筹集了约18.5亿港元。曹操集团是中国第二 大按交易金额计算的网约车服务平台。此次首次公开募股吸引了包括Mercedes-Benz、未来资产 证券在内的六位基石投资者,他们共同认购了价值9.52亿港元的股份。曹操集团在31个城市运营超过 34,000辆订制车辆,并已将其网约车服务扩展到136个城市。筹集的资金将主要用于改善汽车解决方 案、提升技术、投资于自动驾驶、扩大地理覆盖范围,以及偿还部分银行借款。

## **SUCCESS STORY 2**

Appleby acted as Cayman counsel for CaoCao Inc. (together with its subsidiaries, the "Caocao Group") in its successful listing on the Main Board of The Stock Exchange of Hong Kong Limited on 25 June 2025, raising approximately HKD 1.85 billion. CaoCao Inc. is the second-largest ride-hailing player in China by gross transaction value. This IPO attracted six cornerstone investors, including Mercedes-Benz and Mirae Asset Securities, who collectively subscribed to HKD 952 million worth of shares. The Caocao Group operates over 34,000 customised vehicles across 31 cities and has expanded its ride-hailing services to 136 cities. The funds raised will be primarily allocated to improving auto solutions, enhancing technology, investing in autonomous driving, expanding geographical coverage, and repaying part of its bank borrowings.

CaoCao Inc. is a Cayman-incorporated ride hailing company operating a platform across China, originally incubated by the group of Zhejiang Geely Holding Group Company Limited. 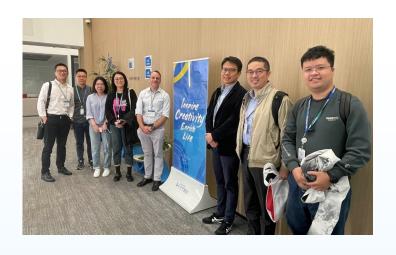

# **SUCCESS STORY 10**

Due to the impact of the pandemic, a purchase contract of automobiles concluded between the seller from Chinese Mainland and the Syrian buyer was terminated, and the Syrian buyer claimed compensation for losses. The legal teams representing both parties hailed from Syria, Hong Kong, and Chinese Mainland and the languages of arbitration are Chinese and English. CIETAC HK arbitral tribunal analyzed the pandemic's impact on the manufacturing industry, correctly applied the force majeure clause, and finally determined that force majeure was established, exempting the Chinese enterprise from tens of millions RMB in compensation.

南非服务商与内地制造企业就开拓南非市场支付剩余服务费产生争议。是否进行证据披露是双方的程序 焦点,贸仲香港仲裁庭明析证据披露对案件审理的必要性和关联性,明确合同解释原则并解读合同条 款,仅用时不到6个月和不到申索金额4%的仲裁费妥善处理纠纷。

# **SUCCESS STORY 11**

A dispute arose between a South African service provider and a mainland Chinese machinery manufacturing enterprise over the payment of remaining service fees for South African market expansion. Whether to conduct disclosure of evidence became the key procedural issue for both parties. The CIETAC HK arbitral tribunal clarified the necessity and relevance of case document disclosure, defined the principles for interpreting contract clauses and interpreted the contractual provisions, and resolved the dispute fairly and impartially within 6 months, with arbitration costs amounting to less than 4% of the claim value.

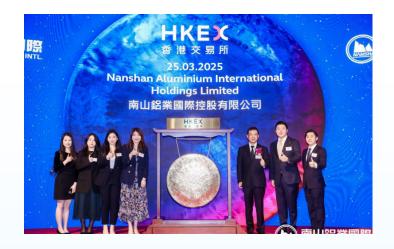

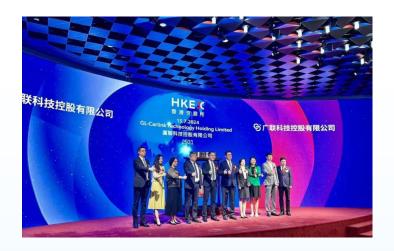

#### **SUCCESS STORY 29**

#### **Litigation and Dispute Resolution**

We represented the Defendant in a high-stakes commercial dispute involving allegations of fraudulent misrepresentation over the purchase of COVID-19 test kits for export to Germany and Mexico, with the Plaintiff seeking recovery of US\$2.7 million and damages. Our team successfully secured dismissal of the Hong Kong proceedings by enforcing an exclusive jurisdiction clause favoring Chinese Mainland courts and invoking forum non conveniens. The matter presented complex jurisdictional enforcement issues, cross-border contractual interpretation under Mainland law, and strategic cost considerations, requiring deep expertise in both Hong Kong and Mainland legal principles. This outcome is significant as it reaffirms Hong Kong courts' strong policy of upholding exclusive jurisdiction clauses in international contracts. By redirecting proceedings to the agreed Mainland forum, we protected our client from protracted litigation in Hong Kong, saving substantial time and resources, and set an important precedent for cross-border disputes arising from pandemic-related transactions.

在初步尽职调查阶段,某央企开展了全面调查,包括地质勘察、矿区潜在产量、基础设施配套及市场分析,包括聘请了一家地质勘察公司编制详细的地质调查报告。尽管经历多轮谈判并克服诸多监管障碍,收购交易最终顺利完成。

后因该地质调查报告存在分析失实及误导性陈述引发争议,导致款项支付违约。该上市公司作为申请人提起仲裁,将某央企列为第一被申请人,地质勘察公司列为第二被申请人。双方先进行了调解,随后进入仲裁程序,索赔金额约5亿澳元。

香港办公室主导了此争议的调解与仲裁。通过专业代理,我们成功将索赔责任转移至地质勘察公司,使 某央企最终承担的金钱损失微乎其微。该案核心争议点在于:尽管存在纠纷,该矿场的采矿权仍然有效 存续。

#### **SUCCESS STORY 33**

Our Firm represented a Central State-owned Enterprise (CSOE) in an International Chamber of Commerce (ICC) arbitration seated in Singapore with Hong Kong laws being applicable. This CSOE through a web of corporate structure invested in a mineral mine in Australia.

A listed company which owned this sizeable mineral mine was purchased by the CSOE in the sum of over AUD 80 million with mining rights of different minerals of over 90 years. At the preliminary due diligence stage, thorough investigations were conducted, including geological surveys, potential output of the mine, infrastructure access and market analysis. A geological survey company was retained and a detailed geological survey report was prepared. Despite numerous negotiations and regulatory hurdles, the purchase was completed.

As a result of the alleged incorrect analysis and misleading geological survey report, there were disputes leading to default in payments. The listed company was the Claimant with the CSOE being the 1st Respondent and the geological survey company being the 2nd Respondent. The parties went into mediation followed by arbitration. The claim amount was in the region AUD 500 million. Our Firm's Hong Kong office was leading the mediation and arbitration. Our Firm managed to pass on the claim to the geological survey company and the CSOE suffered negligible monetary damage. The main issue was that the mining rights continue until this day despite the disputes.

The dispute arose from a technology license agreement relating to the use of the Instruction Set Architecture (ISA) developed by a US company in microprocessors.

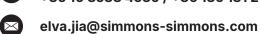

#### **SUCCESS STORY 56**

This HKIAC-administered arbitration stems from an operational and managerial dispute over a joint venture between a state-owned enterprise (SOE) in the Chinese Mainland and its minority shareholders. The dispute centers on the legality of actions taken by the SOE, which it justifies as compliant with state-owned asset supervision regulations. Involving substantial assets and core SOE governance issues, the case represents a rare intersection of state-owned asset supervision, international arbitration, and the application of foreign law.
