活動花絮:第五屆香港調解講座

**Event Highlight: Fifth Hong Kong Mediation Lecture** 



於 2023 年香港法律周期間與史密夫斐爾律師事務所合辦的第五屆香港調解講座:《以調解化解國際爭端—現狀、挑戰與機遇》於 2023 年 11 月 8 日圓滿舉行。在講座中,國際調解院籌備辦公室主任孫勁博士詳細講解了國際調解在化解國與國、投資者與東道國和國際商事爭議的法律框架和實踐,並解釋調解作為國際爭議解決機制的特點。孫博士也討論了國際調解院的建立,同時介紹該倡議的背景、現狀以及國際調解院的潛在角色和功能。講座最後討論了以調解化解國際爭端面臨的機遇和挑戰。孫博士深入淺出的分享釐清了有關國際調解的疑問,令與會者獲益良多。按此重溫孫博士的演講。

As part of the Hong Kong Legal Week 2023, the fifth Hong Kong Mediation Lecture: Resolving International Disputes Through Mediation – Where We Stand, Challenges and Opportunities Ahead, co-organised by the Department of Justice and Herbert Smith Freehills, was successfully held on 8 November 2023. During the Lecture, Dr. Sun Jin, Director-General of the International Organization for Mediation ("IOMed") Preparatory Office, provided a detailed overview of the legal framework and practices of international mediation in resolving state-state, investor-state and international commercial disputes, and explained the features of mediation as an international dispute resolution mechanism. Dr. Sun then discussed the establishment of the IOMed, introducing the background of the initiative, the progress to date, and the potential role and functions to be played by the IOMed. The Lecture concluded with a discussion of the challenges and opportunities for mediation in resolving international disputes. The participants benefited greatly from Dr. Sun's sharing in simple terms, which clarified questions about international mediation. See the full speech of Dr. Sun here.

# 第五次粵港澳大灣區法律部門聯席會議 Fifth Guangdong-Hong Kong-Macao Greater Bay Area Legal Departments Joint Conference



第五次粵港澳大灣區法律部門聯席會議於 2023 年 12 月 7 日舉行·就共同構建通用線上爭議解決平台、推進涉外法治人才培養等議題達成共識。 三方在《<u>粤港澳大灣區調解員資格資歷評審標準</u>》的基礎上,就各自制定調解員資格資歷評審細則及推進設立大灣區調解員名冊的工作等議題深入討論。

The Fifth Guangdong-Hong Kong-Macao Greater Bay Area Legal Departments Joint Conference was held on 7 December 2023, during which consensus on issues including establishing collaborative online dispute resolution platform and enhancing measures to nurture foreign-related legal talents was reached. The three parties have, on the basis of the <u>Greater Bay Area Mediator Accreditation Standards</u>, conducted in-depth discussions on various topics, such as the respective formulation of mediator accreditation rules of each place and the work on promoting the establishment of panels of GBA mediators.

#### What's New

## How much does mediation cost? Who will pay for the costs?

- Mediation costs vary depending on the circumstances of the case.
- The statistics relating to the average mediation costs for cases with mediation reports filed in the Court are available at the website of Hong Kong Judiciary on Mediation (see link on the back page).
- The fees of the mediator (who will typically charge on the basis of his or her respective hourly rate) and incidental expenses such as venue charges are normally paid by the parties in equal shares. Parties may choose to engage lawyers and experts to assist in their cases. These additional fees are to be paid by the parties who engage the services.
- Some institutions provide free mediation services under certain schemes, such as the Free Community Mediation Service Scheme and Free Mediation Service Scheme for Building Management of Home Affairs Department offered by the Hong Kong Mediation Centre. For further information, please visit the websites of the relevant institutions.

### How long does mediation take?

- The duration of mediation varies depending on the circumstances of the case. Relevant factors include complexity of the case and the number of issues in dispute.
- The statistics relating to the average duration of a mediation for cases with mediation reports filed in the Court are available at the website of Hong Kong Judiciary on Mediation (see link on the back page).

## What happens if no settlement is reached at the end of the mediation process?

If no settlement is reached in the course of the mediation, the parties may terminate the mediation and proceed with other modes of dispute resolution, such as arbitration or litigation.

## Is it compulsory to participate in mediation?

No, mediation is entirely voluntary. Nevertheless, if there is an ongoing litigation concerning the dispute or that the dispute is later referred to the Court, the Court may take into account a party's unreasonable failure to mediate in exercising its discretion on costs. Adverse costs order may be awarded against that party. You may wish to refer to Practice Direction 31 — Mediation for more details.

#### **Mediation Ordinance**

The Mediation Ordinance (Cap. 620) came into force on January 1, 2013. It provides a legal framework for the conduct of mediation, without hampering the flexibility of the mediation process.

#### "Mediate First" Pledge Campaign

The "Mediate First" Pledge campaign was launched in 2009 by the Department of Justice to encourage the wider use of mediation. The purpose of the campaign is to encourage companies, organisations and individuals to make a pledge, namely the "Mediate First" Pledge. While the pledge is non-legally binding, it serves as a statement of commitment to first explore using mediation which is a flexible, amicable and constructive approach in

兒童包容性調解讓孩子可以在父母不在場和保密的情況下和調解 員會面。如孩子同意,調解員可以將他們表達的意見全部或部分 轉達給父母。兒童包容性調解給孩子一個表達心聲的機會,從而 令父母在分開後能為他們作最好的撫養安排。

Child-inclusive mediation ("CIM") allows children to speak with a mediator in the absence of their parents in a confidential session. With the children's consent, the mediator may then wholly or partly relay children's view to their parents. CIM aims to let children express their concern. This facilitates the making of better post-separation parenting arrangements.





司法機構在近年推出案件和解會議,在案件管理過程中引入協助和解概念,培養訴訟人及其法律代表樂於嘗試和解的文化。案件和解會議聆案官會協助雙方縮窄爭議範圍,並檢現各方之間無損權益的商議過程(包括任何附帶條款的和解提議及付款)。

Case Settlement Conference ("CSC") was launched by the Judiciary in recent years to introduce the idea of assisted settlement into the case management process and to instill among litigants a culture of exploring settlement. A CSC master will assist the parties to narrow down issues in dispute and review previous without-prejudice negotiations (including sanctioned offers and payments)





調解員輔助的案件和解會議結合案件和解會議和調解,藉著兩者所 發揮的協同效應,利便訴訟各方更早達致案件整體和解或至少達成 部分共識,令爭議能以更合乎成本效益的方法解決。

MCSC is a combination of Case Settlement Conference and mediation. The synergy between them facilitates the parties to reach an overall settlement or at least consensus on some issues at an early stage so that disputes could be resolved in a more cost-effective way.



## 調解為先承諾書

**Mediate First Pledge** 

「調解為先」承諾書不具法律約束力。承諾人 簽署承諾書時,代表他願意先探索使用調解來 解決爭議,然後才嘗試其他爭議解決方式(包 括在法庭進行訴訟)。

The "Mediate First" Pledge ("Pledge") is not legally binding. By making the Pledge, the Pledgee acknowledges his willingness to first explore the use of mediation as a means to resolve disputes before resorting to other dispute resolution processes (including commencing proceedings in courts).
