鄺律師是英國倫敦特許仲裁學會(CIArb)特許仲裁員和資深會員、獲世界知識產權組織(WIPO)委任為(1)仲裁與調解中立人及互聯網域名專家組成員及(2)互聯網名稱與數字地址分配機構(ICANN)的新通用頂級域名(gTLD)計劃下的法律權利異議專家組名單成員、有效解決爭議中心(CEDR)認可調解員、國際公證人、分別在香港(1979年)、英國(1983年)、澳洲維多利亞省(1984年)、新加坡(1989年)取得執業律師資格、被表列為香港國際仲裁中心知識產權仲裁員、仲裁員及審裁員。

他是香港特別行政區專利制度改革諮詢委員會成員、知識產權貿易工作組成員及其轄下仲裁與調解 分組的召集人、律政司所成立的評估式調解特別委員會副主席,也是香港應用科技研究院董事局成 員。

由於他在知識產權方面有突出的貢獻,鄺律師被香港特別行政區政府委任為太平紳士。他是前任香港特別行政區版權審裁處副主席、行政上訴委員會小組成員、稅務上訴委員會小組成員、創新科技界知識產權檢討督導委員會成員。

鄺律師也榮獲《亞洲法律》(Asia Law)雜誌評選為知識產權傑出律師。

He is a director of Hong Kong Applied Science and Technology Research Institute Company Limited (ASTRI).

Mr. Kwong was Deputy Chairman of Copyright Tribunal of the Hong Kong SAR, member of the Administrative Appeals Board of the Hong Kong SAR, Member of the Panel of the Inland Revenue Board of Review, Member of Steering Committee on Review of IP Issues in the Innovation & Technologies Sector.
